
### Greenblatt Library partners to create disaster information portal

When disaster strikes preparation can be key to helping those in need. To ensure that first responders to public health emergencies have the reliable information they need, Greenblatt Library partnered with Georgia East Central Health District to develop a <a href="web portal">web portal</a> to bridge the information gap between public health partners and vital disaster information resources. The web portal was sponsored by funding from the National Library of Medicine (NLM) and highlights key NLM Disaster Information Management Research Center resources.

The <u>web portal</u> design and customized content were developed in response to an information needs assessment survey distributed to the emergency response community. The top local natural disaster risks were identified as tornado, flood, and winter weather. Manmade disaster concerns focus on chemical spills, radiation emergen-

cies and fire. The web portal links to each potential hazard for emergency planning, disaster response and community recovery. The web portal also links to additional disaster topics, mobile resource tools, a guide to public health and disaster medicine, and a directory of disaster organizations. Local resource links include public health websites, coordinating hospitals and emergency services maps, and media communication outlets. Training materials will be developed to focus on identified high risk topics.

#### 'GRU FIT' aims for better health

Over the past 20 years, there has been a dramatic increase in obesity in the United States. According to the Centers for Disease Control, more than 35.7 percent of U.S. adults are obese. The economic consequences of obesity are severe. The "GRU Fit" project is aimed at addressing this important public health problem. GRU Fit is a competitive walking program encouraging greater awareness of fitness and health and is intended to increase physical activity, lower body weight and blood pressure.

Established by Vice Provost Dr. Roman Cibirka and spearheaded by Dr. Vernon Barnes of the Georgia Prevention Institute and Dr. Brenda Seago, Director of University Libraries, GRU Fit has been initially launched for staff in selected departments including University Libraries, Enrollment Management, Ad-

missions, Area Health Education Center, Financial Aid, Office of Global Affairs, PACE, and the Office of the Registrar.

GRU Fit participants receive a pedometer and are given a daily walking distance as well as optional stress reduction modules sessions. Participating staff in these initial departments are split into teams and will compete for combined distance (steps) walked per week as measured by pedometers. Nearly 100 employees have signed-up to participate in this eight week program.

Free 'PubMed® for Trainers' and 'TOXNET® and Beyond' CE Classes Hosted by Mercer University School of Medicine— Savannah Campus/Memorial University Medical Center

#### PubMed® for Trainers:

Would you like to gain new skills, brush up on existing PubMed skills and collaborate with colleagues to help create effective training strategies? The NTC, along with the Memorial Health University Medical Center in Savannah, GA, is offering PubMed® for Trainers (PMT). PMT is held in 4 sessions; 3 online and 1 in person session (attendance in all is expected).

The last of the four sessions will be in-person at the Memorial Health University Medical Center in Savannah, GA. Upon completion, the class is eligible for 15 hours of MLA CE credit.

# The class runs from October 31 – November 14, 2013.

This hands-on course consists of 9 presentations created by the National Library of Medicine, live demonstrations, hands-on exercises, group work and discussions, and networking opportunities over the course of four sessions. You can expect an additional 2-3 hours of independent homework.

#### **TOXNET®** and Beyond:

This 1-day course is designed to convey the basics of searching the NLM's TOXNET®, a Web-based system of databases in the areas of toxicology, environmental health, and related fields. The course will also teach students how to utilize NLM's environmental health and toxicology portal which provides resources beyond the TOXNET® databases. Students will learn the content and structure of files covering toxicology data, toxicology literature, toxic releases, and chemical nomenclature.

Among the databases highlighted will be TOX-LINE, the Hazardous Substances Data Bank (HSDB), the Integrated Risk Information System (IRIS), the Toxic Release Inventory (TRI), and ChemID*plus*. The course, taught by NLM instructors, will be conducted in a computer lab and includes lectures, online demonstrations, and handson exercises.

TOXNET® is a **free** class and is awarded **6.0** MLA continuing education credits.
